A shut down is planned in our Izmit Refinery Fuel Oil Conversion Unit (operating since 2015) due to periodic maintenance , which is technically required in every 4 years with suspension of all units. Some equipment changes regarding improvement investments will also be completed in addition to the maintenance activities; total duration of maintenance is planned 90 days.

Although no reduction is foreseen on Tüpraş' sales volume as production loss will be compensated by increased imports, Battery shut down is expected to decrease the monthly EBITDA by \$40 million.
